Sorry for the delay on getting back to you about the dumpster violation fees, things have been so busy. I just looked up the current open violations for prop 170 and put together a spreadsheet with them. See the attached.

The good news is some of the ones from 2018 seem to have been removed. The bad news is there's still \$6,810.00 total in fees for prop 170.

Shana Simon may have advice on who to contact to get these removed or reduced. She's the only one who successfully disputed these. It took a loooong time for the city to respond and process everything, but we finally got a response and they reduced the fees for prop 131 by over half.

If you'd like me to pay half now, you can indicate which ones you'd like me to pay in the "Ok to pay?" column in the excel sheet, you can put a Yes in there and I will get the marked ones paid.
