Property Order Form

This Property Order Form ("**POF**") is at all times subject to the terms and conditions of that certain Master Services Agreement, dated as of January 27, 2023 (the "**Agreement**"), by and between Domuso Inc. ("**Domuso**") and Lindy Property Management, Inc. ("**Client**"). This POF is entered into as of 09/01/2024 (the "**POF Effective Date**") and is hereby incorporated into the Agreement. Any capitalized term used, but not defined, in this POF will have the meaning given to that term in the main body of the Agreement.

- 1. **Domuso Service.** Client is entering into this POF on behalf of each of its clients (each, a "**Property Owner**") with respect to their respective Properties, as more fully described in <u>Exhibit A</u> of this POF.
- 2. Client Content. Client and Property Owner acknowledge that (a) Client's and Property Owner's timely response and delivery of Client Content and other information requested by Domuso is essential to the performance of the Domuso Service, (b) Domuso will not be liable for any failure to provide the Domuso Service if such failure results from Client's or Property Owner's failure to provide such requested Client Content and/or other information on a timely basis, and (c) Client's or Property Owner's failure to provide such requested Client Content and/or other information will in no way negate Client's and Property Owner's obligation to pay Domuso the fees set forth in the table below.
- 3. **Term.** The term of this POF will commence on the POF Effective Date and will continue until the termination of this POF by Domuso, Client or Property Owner pursuant to the terms of the Agreement.
- 4. **Effect of Termination**. Upon the termination of this POF for any reason: (a) all rights and licenses granted to the Property Owner will immediately terminate, and (b) the Property Owner shall immediately stop using the Domuso Service. Termination of this POF will not relieve Client or Property Owner of any obligation to pay Domuso the fees accrued upon the date of such termination. Domuso will complete any Payments in process at the time of termination and will deduct any fees owed to it at that time. Any party's termination of this POF will be without prejudice to any other right or remedy that it may have at law or in equity, and will not relieve any party of breaches occurring prior to the effective date of such termination.
