

### B. PERSONNEL

Shifts longer than 5 hours will include a lifeguard break. Pool will be closed to swimmers at this time. Unless otherwise specified, pools will be staffed with one lifeguard during the operational hours. Pool will be open weekends only from 5/27-6/19, then 7 days a week through 8/27. The pool shall be closed during the week of 8/28-9/1, and will re-open full time for Labor Day Weekend. Lifeguards are scheduled 1/2 hour prior to opening for each shift. Pools staffed with J1 student lifeguards will be closed 1 weekday in early August in order to allow students to participate in a required cultural immersion day trip. Any missed swimmable hours due to staffing shortages will be credited back at a rate of \$14.35 per hour. Community also reserves the right to use any said hours to extend the pool season past Sept 4th if weather allows.
