Description of Incident

On August 17, 2022, Dawn received a call from Patrick and Ticcira Rose who resides in Regency 102. Patrick asked about transferring to an apartment on a higher floor due to a shootout outside of Regency House. The Roses informed us that the incident occurred August 16th around 9:30p-they report that there was one man shooting outside the building. After reviewing the cameras, I was able to see two African American men running towards Regency House and away from 10th street. One man ran towards the parking lot of Regency and the other went in the vestibule and passed out. Police arrived on the scene, carried the man out and we assume, rushed him to the hospital. After speaking with Detective Harron who is assigned to the case, he informed me that the male needed emergency surgery and he did not have any further details at the time. I contacted Courtesy patrol, The Philadelphia Protection Unit, and they were not on duty that night. Today, on August 18, 2022, Ephraim Reaves who resides at Regency 208 called to inform me that the men in question were supposedly driving a stolen vehicle that crashed into his Impala, which was towed away due to damage. The suspects were driving a Hyundai. Detective Harron informed me that the victim doesn't appear to be living at Regency, but he was not sure. The detective came to the office to speak with me, and will be retrieving a copy of the camera footage. I informed him that we planned on sending an email to the residents asking if knew any information and to email the detective. The detective email address is Charles.Harron@phila.gov. The details of the event are still under investigation, and further details will follow.
