#### **Description of Incident**

At 3:20 pm on 9/11/23, Cianni Hudson (resident services rep) was leaving work to take her lunch break. Her black Hyundai Tuscon was parked in the 3rd space in the row across from A bldg main entrance. Vanessa Jones (resident) was coming down the lane in her silver Kia Optima to find a parking space. Cianni backed her vehicle up and did not see Ms. Jones' car. Cianni caused damage to Ms. Jones' vehicle on the front drivers side bumper. Cianni's vehicle had damage to drivers side area next to wheel well. There were no injuries reported from the accident.

### Corrective action taken at the time of the incident

Cianni and Ms. Jones inspected each others vehicles and exchanged contact information. Cianni reported the incident to me, Dawn Buck (community director), when she returned from lunch.

### What we have done related to Customer Service and helping the resident, if anything?

I called and left a message for Ms. Jones once I was notified of the incident. When Cianni spoke to Ms. Jones again on 9/12, they agreed to not go through insurance. They agreed to get two estimates and Cianni agreed to pay for damages. When I spoke to Ms. Jones on 9/12, I apologized that the incident happened. Ms. Jones stated to me that it appeared Cianni was not paying attention and was on the phone when accident occurred, as Cianni was still on the phone when she exited her vehicle. Ms. Jones stated that she did not want to go through insurance if she didn't have to, but wanted to be sure camera footage was retained in case Cianni does not fix her vehicle in a timely manner.
