Description of Incident

On the evening of October 27, 2024, Kenneth Eady, a visitor in PH12-2 who had been illegally occupying the premises for the past year, was involved in a domestic dispute with three residents. Alexis Anderson contacted the police around 10:30 PM. At 10:55 PM, video surveillance captured Kenneth walking down the north PH hallway carrying a trash bag of belongings and a dog. He then discharged a firearm down the hallway, striking the mirror at the elevator landing and causing damage. The police arrived at the Tower 2 lobby while Kenneth was exiting, but they did not initially recognize him. The investigation began on Monday morning, October 28, when Rachel Polk, a resident of PH17, brought a shell casing found by her roommate to the concierge. She later met with us and mentioned that she thought she heard a gunshot during the previous night but had not reported it at the time. As of now, we have not received any additional inquiries from residents regarding the incident or reports of hearing anything unusual. I met with the police at 8:30 AM on Monday to discuss the situation, and Linda and I reviewed the camera footage afterward. Detective Timothy Filloon (#1035) from Cheltenham Township identified Kenneth as the visitor involved. (we are waiting for formal police report)

Corrective action taken at the time of the incident

The damage to the mirror has been covered with temporary signage, and repairs are scheduled for Monday, November 4. On October 31, at 10:30 AM, Linda and I spoke with Tameko Peterson, the mother of a resident. Later, at 3 PM, we met with Alexis Anderson, the shooter's girlfriend and an adult daughter on the lease. We communicated the terms of the 10-day notice to quit and our expectation for the premises to be vacated by November 9, 2024.

What we have done related to Customer Service and helping the resident, if anything?

Linda and i met with concerned neighbor (Rachel Polk/Arcadia student) who found the casing and spoke with her father several times.

There is a resident walking behind the shooter in the footage, however to date, no one has been able to identify him. Rachel and roommate were not witnesses to the event only they found the evidence the following day.
