Description of Incident

Around 3:50 pm on 10/28, there was a report of fighting going on with 2 woman and the occupant in apt 612. (There had been a previous report of noise disturbance and upon investigation, it was found that the lease holder, Carmen Young, was not staying there and was allowing her disabled daughter, her boyfriend and the nurse aid to stay there. Names are unknown. She was told they must vacate, and the account was non renewed. Carmen came to the office and provided notice to vacate and informed us all parties would move out on 10/28.) After reviewing the cameras, this is what was determined: As the unauthorized occupants were preparing to move out on 10/28, the 2 women, sisters of the occupant, came into the building and engaged in a confrontation with her in the apartment. Shortly after, the brother of the women entered the Leasing office, requesting staff to call police and asked if his 8 year old daughter could sit in the office for safety. Charlesity called Thomas for help and called the police. The confrontation in 612 spilled out into the elevator area of the 6th floor, where one of the women, picked up the coffee table and threw it against the wall, breaking it. She then took a fire extinguisher and prepared to use it. She then sat it down and took a shoe and threw it at someone off camera. Both girls then took the elevator back to the lobby. On the lobby camera, the 2 girls are seen going into the leasing office. The woman then comes up and slaps the 8 year old and started spitting on her. Charlesity walked over, telling her stop and to leave. The women yell at Charlesity and new employee, Brittany, and told them they would be back to f*** everyone up, then they left. Thomas arrived shortly after to comfort Charlesity and Brittany because they were upset. The police arrived around 4:30pm to go the apartment and talk to the occupants. On Sunday, building cleaner Lorraine saw the occupants throwing trash into the hallway by the trash room before they finished moving out. She took photos and sent them to Shaw
