## **Description of Incident**

On 12/3/2021 Brandy Shinn leasing temp received a call from the resident in R 203 stating that water was leaking in the bathroom through the exhaust fan on the ceiling. Maintenance went to R303 to check the bathroom and the resident was not home. Brandy Shinn contacted the resident by phone and received their voicemail, she left a message letting the resident know we had an emergency, and a leak was occurring from the tub, and we would be entering to make repairs. Maintenance entered the apartment and observed numerous firearms and ammunition. Melvin Draughn maintenance technician relayed what he observed to Brandy, and she contacted Nancy Benner. Nancy Benner reached out to Michael Jacobus and Michael instructed that maintenance should make the repairs and leave a door tag. The plumbing issue required a plumber and Ben Manis plumbing arrived to make the repairs. The resident returned home and spoke with Melvin and asked that they not enter the bedroom. The resident had to leave and was aware the plumber needed to make repairs. The plumber left to get parts, and while waiting for his return Brian Kroker instructed that we contact the police to report the weapons and ammunition being stored in the apartment and wait to have the plumber go back in until the police arrived and confirmed all was ok to do so. Nancy Benner called 911 and reported the information and met with the police upon arrival to the community. The police arrived and relayed that there was not a limit to how many firearms or ammunition a person could own and that they had no need to go to the apartment. They were shown a photograph of a portion of what was observed however they still relayed there was nothing to be done on their end and we should call if anything additional was needed. Nancy Benner requested a dc number and the officer provided it and left. DC# 21-02-052500. Nancy reported the information back to Brian Kroker and he relayed we could resume repairs in R303.

## Corrective action taken at the time of the incident

Nancy Benner contacted Michael Jacobus and spoke with Brian Kroker. Nancy Benner called 911 to report the information and met with the police upon their arrival to the community and obtained DC#21-02-052500. On 12/6, John Samuel filled in a lead to FBI website (https://tips.fbi.gov/) regarding storing of weapons in the unit.
