Narrative

On March 13, 2024, I spoke with Nikole KOBCHENKO via telephone in reference to an accident she was involved in on March 9, 2024. KOBCHENKO stated after she viewed the accident report, she wanted to dispute the narrative and diagram which was presented. According to KOBCHENKO, she had proceeded through the intersection at Huntingdon Pike and Meadowbrook Rd and had made a left turn onto northbound Huntingdon Pike. KOBCHENKO stated she proceeded through the intersection only after waiting for her traffic signal to turn green. KOBCHENKO stated she had completed the left turn and was proceeding northbound when she felt her vehicle get struck by vehicle #2 on the rear quarter panel area. According to KOBCHENKO, the impact of the contact caused her vehicle to fishtail and spin out of control, sending it into oncoming traffic lanes and through a fence. KOBCHENKO showed damage evidence that would be consistent with this narrative.

KOBCHENKO (vehicle #1) had damage to the rear passenger side quarter panel area. Vehicle #2 had damage to the front driver side fender area.
